

Rescue Technician Program: 84 Hours, 24 EMT Elective CEU's, Limit: 50 Students

Fee: \$70.00 Tuesdays and Thursdays - 7:00 p.m. to 10:00 p.m. and two Saturdays - 8:00 a.m. to 4:00 p.m.

Course Starts: Tuesday, September 6, 2011 at 7:00 p.m. Course Completion: December 15, 2011

The Rescue Technician Program is being run in association with the Maryland Fire and Rescue Institute at the Bergen County EMS Training Center. This program will address a broad based approach to special rescue needs. Areas to be addressed include site operations, resource/victim management, maintenance of tools, apparatus, hardware and ropes/rigging/mechanical advantage systems. Additionally, specialty rescue areas such as vehicle extrication, confined space, trench and water rescue. This class will also include SCBA, Hazardous Materials as well as Gas and Electric Emergencies. Students must supply NFPA approved fire fighting gear. Students must be 18 years of age at the start of this course.

Books are not included - they may be purchased at the EMS Training Center at the beginning of the course.

<u>Fire-Rescue Vehicle Extrication:</u> 10 EMT Elective CEU's - Attendance mandatory at all 3 sessions for CEUs.
